# CODE OF ETHICS FOR THE MANAGEMENT OF THE EUROJUMELAGES WEBSITE

## **Article 1 - Purpose**

EUROJUMELAGES is developing a website, the purpose of which is to promote and present the activities and decisions implemented by the association and, where appropriate, of its federated associations.

#### **Article 2 - Name**

This website domain name is www.eurojumelages.eu

#### Article 3 – Responsibility of the website and appointment of the webmaster

The website is under the direct responsibility of the EUROJUMELAGES Board of Directors, who appoints on the President's proposals, the webmaster in charge of the implementation, management and daily updating of this site. This appointment is mentioned on the Board meeting minute. A deputy webmaster could be appointed by the Board of Directors in order to help the webmaster or to substitute in case of absence.

The webmaster can be a member or non-member of the EUROJUMELAGES Board of Directors. He cannot be an auditor who has been elected at the general meeting according to the article 22 of the by-laws.

#### **Article 4 - Access**

Access codes to the server and passwords are managed by the webmaster after agreement and approval of the President.

The president, webmaster and any other person duly appointed by the Board of Directors are owners of the information referred to in the preceding paragraph of this article. These are confidential and not disseminated.

## Article 5 - Applicable Law

EUROJUMELAGES is currently an association under French law, the code of the intellectual property defined by Law No. 85-660 of 3rd July 1985 applies.

Protection of the private person and his image (in the photographic and moral sense, his voice, name, etc.) are met by the Data Protection Act (Law No. 78-17 of 6th January 1978 and subsequent decrees) apply equally. Its provisions stipulate that no identifying information (including email addresses) can be disclosed on the EUROJUMELAGES website without written consent of the persons concerned and without declaration to the CNIL¹ of all the files created.

The provisions of Law No. 2004-801 of 6 August 2004 on the protection of individuals with regard to personal data processing must be taken into account by the webmaster before launching a programme.

## **Article 6 - Quality of information**

The information contained on the website must be clear, accurate, written with care, and reveal nothing of a confidential nature.

Search engines visit the website to enable the contents to be known worldwide so the quality of the information disseminated above mentioned must be faultless.

Proofreaders in French, German and English and in any other language used on the website to disseminate information are appointed by the Board of Directors.

Information or photos on a completed activity are immediately removed from the site by the webmaster.

#### Article 7 - Insertion of information on the website

Information sent to the webmaster or to EUROJUMELAGES and intended to be inserted on the website must comply with the provisions of this Code. The President, Head of the Communication Committee and the webmaster will approve the appropriateness of such insertion. In case of doubt, the Secretary General, in charge of the legal texts of EUROJUMELAGES, will be consulted for advice.

#### **Article 8 - Licensing and Intellectual Property**

The chairman of EUROJUMELAGES must obtain written permission from the author, publisher or other rights holders before the distribution of a text, photographs or artwork.

Hyperlinks may relay to an explanation generated by some text, or may be a reference to a page linked from a server other than the home page. Direct links to home pages are preferred.

The laws of a country in terms of copyright (and therefore reproduction) are often different to French law. In this respect, the President, Head of the Communication Committee and the webmaster should be attentive to the texts inserted on the EUROJUMELAGES website.

# **Article 9 – Offensive content**

The Head of the Communication Committee must check before each publication that no information implies a press offence listed below :

- Incitement to criminal offences
- Denial of crimes against humanity
- Propagation of false information
- Defamation
- Racial or sexual discrimination
- Offence to a country or a region
- Offence to Heads of State, Governments and diplomats
- Incitement to suicide

#### **Article 10 - Respect for others and humanity**

To meet the rules and regulations of EUROJUMELAGES, no information of a political nature will be disseminated through the association website. The Head of the Communication Committee is responsible for ensuring compliance with this rule and determination of the political nature of any information.

Pornographic information or links to such will be systematically excluded from any publication or reference to the EUROJUMELAGES website.

The information provided will never glorify verbal or physical violence.

### **Article 11 - Discrimination**

No information that has a discriminatory comment referring to race, ethnic or national origin, religion, age, sex, marital status or disability, physical or mental, is allowed on the site.

#### **Article 12 - Protection of children**

Laws and legislation relating to the protection of children and minors will be scrupulously respected.

Regarding the image rights of children, the consent of either parents – or this in charge - is required before any publication on the EUROJUMELAGES website.

## **Article 13 - Publicity**

Several companies offer creators and website managers display systems, banner advertising, partnership or affiliation. They allow the possibility of occasional income.

These advertisements must be appropriately supervised by the Board of Directors. Informed and consulted, it will have to approve them.

An obligation to report the sums collected to the tax authorities might be considered necessary.

## **Article 14 - Liability**

In relation to the terms of the Act, the director of the publication (the president of EUROJUMELAGES and the editor (the webmaster) are responsible civilly and criminally for everything that appears on the website.

# Article 15 - Publishing of this code of Ethics

This current Code of Ethics of the EUROJUMELAGES website is published on www.eurojumelages.eu

It is also annexed to EUROJUMELAGES Internal Regulation.

It will be reviewed each time the host country laws of EUROJUMELAGES for the management of Internet sites or intellectual property rights will be changed.
